The complainant Sri. Anil Prasad is present in person and has stated that despite discovering of the misappropriation and embezzlement of government fund by Sri. Rajesh Kumar, Block Agriculture Officer, Sarmera, Sri. Ritesh Kumar, the then Krishi Samanyawak, Sarmera, presently working as Krishi Samanyawak, Harnaut, and Sri. Abhimanyu Kumar, the then Kisan Salahkar, Sarmera, presently a Chayan Mukh Kisan Salahkar, Block-Nursarai, no effective step has been taken either to recover the amount from them nor the District Agriculture Officer, Nalanda, has even cared to file a self contained written report to the police as a result whereof the F.I.R has become useless and the aforesaid three accused persons are getting the benefit of doubt on account of sketchy investigation being

conducted by the police in Sarmera P.S. Case No.118/16 dated 05.12.216 under Sections-420/409/120(B) of the Indian Penal Code. The complainant also explains that his effort to get the culprits punished both in the criminal prosecution as also recovery proceedings of the amount misappropriated by them has gone in vain despite his approaching all the concerned authorities including the Divisional Commissioner, Patna Division and Collector of Nalanda District.

Having heard the complainant in person and also perused the averments made in the complaint petition this Authority would find it necessary to initiate its own enquiry by seeking a report from the Collector of Nalanda District as well as Director, Agriculture, Bihar, Patna, who would be under obligation to get the records and information from the office of District Agriculture Officer, Nalanda, and submit their reports after their careful perusal in the

background of the allegations made by the complainant in the complaint petition.

Apart from them the District Agriculture Officer, Nalanda, and Superintendent of Police, Nalanda, will also explain as to what action have been taken in the criminal case and whether the amount sought to be recovered has been made the subject matter of investigation. Let it be kept in mind that the allegation of the complainant is that around Rs.40 Lakhs have been misappropriated by the aforesaid three officer(s) which now has been also found to be true and a criminal case has been lodged but then the District Agriculture Officer, Nalanda, having filed a sketchy F.I.R with a view to favour the accused persons has created an impediment in the investigation by the police. Thus, both the District Agriculture Officer and Superintendent of Police, Nalanda, must file their separate report as with regard to the allegations made by the complainant.

The Director, Agriculture, Bihar, Patna, is also directed to enquire the matter himself or entrust the enquiry to a senior officer to unearth the whole racket involving Sri. Rajesh Kumar, Block Agriculture Officer, Sarmera, Sri. Ritesh Kumar, the then Krishi Samanyawak, Sarmera, presently working as Krishi Samanyawak, Harnaut, and Sri. Abhimanyu Kumar, the then Kisan Salahkar, Sarmera, presently a Chayan Mukh Kisan Salahkar, Block-Nursarai. He will also in his report make it clear as to how much amount in total has been misappropriated and how does he intend to recover it from the erring officer(s)/employee(s).

Put up this case for further enquiry and hearing as a part heard and tied up matter on 03.01.2018 by which time the Director, Agriculture, Bihar, Patna, the Collector of Nalanda District, the Superintendent of Police, Nalanda, the District Agriculture Officer, Nalanda and the Superintendent of Police, Nalanda, must file their respective

reports/explanations in the light of the allegations made in the complaint petition and the observations made in this order.

On the aforesaid date of enquiry apart from the complainant a senior officer of the office of Director of Agriculture, Bihar, Patna and Collector, Nalanda, must remain present in person whereas the District Agriculture Officer, Nalanda, and the Officer-In-Charge of Sarmera Police Station, must remain present in person.

Let a copy of this order be sent to the complainant by Registered Post and its another copy alongwith the complaint petition filed by the complainant alongwith its enclosures be sent to the Director, Agriculture, Bihar, Patna as well as to the Collector of Nalanda District and Superintendent of Police, Nalanda, both by Fax and Email, whose office will be under obligation to supply the same to the Superintendent of Police, Nalanda, District Agriculture Officer, Nalanda and Officer-In-Charge
