INVITATION OF COMPETITIVE BID FOR SUPPLY, INSTALLATION, TESTING & COMMISSIONING OF 16 FT. X 8 FT. SIZE ELECTRONIC DISPLAY BOARD (LED) WITH FOUNDATION & FRAME ETC.

Bihar State Agriculture Marketing Board (Dissolved), intends to install 16 ft. x 8ft. size electronic display boards (LED) with up-to-date technical specifications with construction of foundation/required columns/frames and all other required affixtures etc. to complete the work in all respects at five Marketing Yard's viz Musallahpur (Patna), Gulabbagh (Purnea), Biharsharif (Nalanda), Gaya & Muzaffarpur through reputed companies selected through sealed tender under two bid system. The installation of LED Boards in all the specified market yards shall be done at the height of minimum 5 metres from ground level (up to bottom of LED Board).

(A) BRIEF OF WORK :-

The brief scope of work is outlined below:

| 2. | Foundation of the structure including framework: The selected bidder will execute the work of foundation and steel framework with design of foundation/frame duly proof checked by premier Technical Institutes like IIT's, NIT's or reputed/certified Civil/Structural Engineers in India for safety of the framework for various loads including wind load. |
| 3. | It will be selected bidder responsibility to get the comprehensive quality inspection of LED Board from the competent organization/authority/firm and submit certificate in this regard before commencement of work |
| 4. | The selected Bidder shall provide comprehensive onsite warranty & maintenance for a period of three (3) years after the expiry of the specified warranty period of LED Board by the manufacturing firm. |
| 5. | The selected Bidder shall arrange all the related tools, equipments to install and test run the LEDs. |
| 6. | The selected Bidder shall obtain all necessary approvals from the concerned departments and local authorities before installing the LEDs on the site specified by the Bihar State Agricultural Marketing Board (BSAMB). However, BSAMB shall provide full assistance in obtaining the requisite approvals. Any required fees for the purpose shall be borne by the selected Bidder. |
| 7. | The selected Bidder shall ensure that the Display should be 24 Hrs visible i.e. during the day light and in night time and should work in all weather conditions. |
| 8. | All charges towards supply and installation of LEDs along with the cost of |

| 10. | The maintenance of electronic display boards will be done by the agency itself for three years beyond the expiry of warranty period. (The rate for maintenance of the electronic display board should be quoted in terms of Rs. per year so that the maintenance period may be increased accordingly as per requirement. |
| 11. | The selected Bidder shall be responsible for acquiring comprehensive insurance including transit insurance, liability insurance and any other insurance including any incidental loss/damage for the LEDs including other accessories since the transportation to delivery and commissioning by the Bidder up to three (3) years of completion of warranty. All costs related to insurance shall be borne by the selected Bidder. The Insurance Certificate shall form a part of the final acceptance sign off document. |
| 12. | The entire cost of transportation from the Manufacturing Plant or Port of Landing to the designated location/sites as specified by BSAMB shall be borne by the selected Bidder. |
| 13. | Bihar State Agriculture Marketing Board is under process of invitation of another tender for development of software for display of rates of various commodities sold/purchase in the marketing yards on the proposed LED Boards. The selected agency for the subject work of installation of LED Board will maintain coordination with the agency to be selected for software development to ensure testing/commissioning of the LED Boards. |

B. TWO BID SYSTEM:

Two separate sealed envelopes should be submitted as per details given below:-

1. ENVELOPE NO.1 (SEALED)

This envelope should be addressed to Administrator, BSAMB (D) and marked as **ENVELOPE NO.1- "Technical BID for Supply, Installation, Testing & Commissioning of 16 ft. x 8 ft. size electronic display board (LED) with up-to-date technical specifications etc."** and it should contain papers viz EMD, proof of cost of tender document, Technical Bid with Performa (Annexure- I) duly filled up, an affidavit as per Performa [Annexure-1(A)] etc. The same has been marked as Part-I (Technical Bid) in the tender document. Documentary proofs regarding Bidder fulfilling the eligibility criteria for participating in the bid should be submitted as part of the Technical bid submission.

Bidder should invariably mention their name complete address etc. along with seal on left hand side of the sealed envelope for clear identification. Bidder should also mention tender notice no. on top of the sealed envelope.

The Authorized Signatory signing the Bid on behalf of the Bidder should be duly authorized by the Board of Directors of the Bidding Company to sign the Bid and the Contract/Agreement on their behalf. A Certificate from the Company Secretary of the Bidder certifying that the Bid signatory is authorized by the Board of Directors of the Company to do so, with resolution number and date shall form part of the Technical Bid.

ENVELOPE NO.2 (SEALED)

This envelope should be addressed to Administrator, BSAMB (D) and marked as **ENVELOPE NO.2- "Financial Bid for Supply, Installation, Testing & Commissioning of 16 ft. x 8 ft. size electronic display board (LED) with up-to-date technical specifications etc."** and should contain the rates duly filled up by bidder in the Performa (Annexure- II) for financial bid. The same has been marked as Part-II (Financial Bid) in the tender document.

Bidder should invariably mention their name complete address etc. along with seal on left hand side of the sealed envelope of financial bid also for clear identification. Bidder should also mention tender notice no. on top of the sealed envelope.

2. Both envelopes should be placed in one big sealed envelope super scribing **"Tender For Supply, Installation, Testing & Commissioning of 16 ft. x 8 ft. size electronic display board (LED) with up-to-date technical specifications etc."** and Tender Notice Number. The bidder should invariably mention their name, complete address etc. along with seal on left hand side of this big sealed envelope also and should be addressed to Administrator, BSAMB (D). The tender notice no. should also be mentioned on top of this big sealed envelope.
3. Tenders can be dropped in prescribed tender boxes placed in the offices of Bihar State Agriculture Marketing Board (Dissolved), Patna on **21-11-2019 up to 2.00 PM** and tender will be opened on **21-11-2019 at 3.30 PM** in the office of **Bihar State Agriculture Marketing Board (Dissolved), 1st Floor, Pant Bhawan, Jawahar Lal Nehru Marg, Patna-800001 (BIHAR)** in presence of bidders or their authorized representative present at the time of opening of the tender. If the office is closed on the stipulated date and time due to some unforeseen holiday, tender will be dropped and opened on the next working day at the same place & time respectively.
4. Tender can also be sent to **Bihar State Agriculture Marketing Board (Dissolved), 1st Floor, Pant Bhawan, Jawahar Lal Nehru Marg, Patna-800001 (BIHAR)** by registered post/speed post/courier service to reach before **21-11-2019 up to 2.00 PM Hrs.** of the date of dropping as mentioned above. However, BSAMB (D) will not be responsible for non receipt or delayed receipt of such tenders.
5. Financial bids will be opened on later date (separately communicated to bidders) of only those bidder, who have qualified in technical bids as per criteria laid down.
6. Rate shall be quoted in the Performa of financial bid in word as well as figure in Rupees. The so quoted rate shall include all applicable taxes etc. if any. BSAMB (D) will not entertain any additional amount on account of taxes etc. claimed by bidder/agencies.
7. No addition/alteration/deletion should be done in the tender document by the bidder; else the tender will be rejected. If any 'modification done' is detected



provided in the original tender documents will prevail and will be binding on both sides.

8. Any extra information, if bidder wishes to furnish, the same may be provided on separate letter head of the bidder attached with tender document
9. Bidder will have to sign all the pages of tender document along with Seal before submitting the tender document in sealed envelope.

C. ELIGIBILITY CRITERIA FOR QUALIFYING IN TECHNICAL BID.

The bidder should satisfy all of the following eligibility criteria's for qualifying in technical Bid

D. VALIDITY PERIOD OF TENDER (BID VALIDITY PERIOD)

Tender/offer will be valid for 180 days from the date of opening of the tender. EMD will be forfeited if the bidder withdraws or alters its bid/offer during the bid validity period.

E. EARNEST MONEY/BID SECURITY

1. The tender shall be accompanied by interest free EMD of Rs. 2,50,000/- (Rupees Two lakh & fifty thousand only) in the form of Demand Draft/Banker's cheque drawn in favour of Bihar State Agricultural Marketing Board, Payable at Patna executed by any of the Nationalized Banks/Commercial Banks. The EMD should be valid for a period of 30 days beyond the validity period of the tender/bid. Tender without EMD will be summarily rejected.
2. Exemptions for submission of EMD will not be entertained at all in any case. EMD of unsuccessful bidders, will be returned within a period of one month of the finalisation of tender.
3. EMD will be forfeited if the bidder withdraws or alters its bid/offer/rate during the bid validity period/tender validity period.

F. PERFORMANCE SECURITY

1. Performance security will have to be submitted by the successful bidders within fifteen days of receipt of supply orders/Acceptance letter/Work order. Performance security will be @5% of the total awarded cost of the work. The performance security deposit will be in the form of Account Payee Demand Draft, Fixed Deposit receipt from a commercial Bank or Bank Guarantee from a commercial bank in a form acceptable to Bihar State Agriculture Marketing Board (Dissolved). No interest will be claimed by the supplier/bidder on the Performance Security Deposit. Failure to submit the Performance Security will imply forfeiture of EMD. Performance security deposit should be valid for period of 60 days beyond the date of completion of work/supply as mentioned in the supply order/Acceptance letter/Work order. The EMD deposited along with the tender by successful bidder may be adjusted against Performance Security.
2. **Forfeiture of Performance Security:** Performance security is to be forfeited and credited to the Bihar State Agriculture Marketing Board in the event of a breach of contract by the agency.
3. **Refund of Performance Security :** Performance security will be refunded to the supplier without any interest, whatsoever, after it duly performs and completes the contract in all respects but not later than 60 days of completion of all such obligation under the contract.

G. EVALUATION/ACCEPTANCE CRITERIA OF BID

1. Contract will be awarded to the eligible bidder (successfully qualified in technical Bid) who will be lowest after evaluation of financial Bid. In the event of quoted price of the eligible lowest bidder not found justified/not found reasonable by tender/purchase committee, negotiation can be held with him for reduction in rate. Negotiation should normally be avoided and should be resorted to only in unavoidable /urgent cases when there is urgent need for purchase.
2. Conditional offer shall not be accepted by Bihar State Agriculture Marketing Board (Dissolved) and the bidder shall not impose any term/condition which has not been accepted by tender committee during evaluation of tenders.
3. BSAMB (D) reserves the right to accept/reject any or all of the tenders without assigning any reason whatsoever.

H. PERIOD OF COMPLETION OF WORK

The work of Supplying, Installation, Testing & Commissioning of electronic display board (LED) with construction of foundations and steel frame complete in all respects in five Marketing Yard's viz Musallahpur (Patna), Gulabbagh (Purnea), Biharsharif (Nalanda), Gaya & Muzaffarpur should be completed within 90 days (within three months) from issue of work order/Acceptance letter .

J. PROCEDURE FOR PAYMENT

- (1) The full and final payment will be made after completion of work in all respect including its testing/Demonstration. However payment for completion of work in different marketing yards may be made in sequences/in phases as the work gets completed at such location.

- (2) The concerned SDO – cum – Special Officer looking after the work of concerned marketing yard will supervise the work and submit the bill duly forwarded by him to the Bihar State Agriculture Marketing Board (dissolved) office Patna for payment to the agency after completion/commissioning/testing of work duly certified by him.

K. MAINTENANCE

The maintenance of electronic display boards (LED) and its accessories will be done by the agency itself for three years beyond the expiry of originally specified warranty period. The maintenance period will start after the warranty period as given by company for the equipment is over.

L. OTHER TERMS AND CONDITIONS

1. In case of incompletion of work due to inefficiency of the selected agency, BSAMB(D) reserves the right to get the work completed from next higher bidder at the accepted rate of lowest bidder.
2. The successful bidder shall at his cost execute an agreement with BSAMB (D) on non-judicial stamp paper for Supplying, Installation, Testing & Commissioning of 16 ft. x 8 ft. size electronic display board (LED) with up-to-date technical specifications with construction of foundation/required columns/frames and all other required affixtures etc. to install the LED Display board at height of 5 metres from ground level (up to bottom of LED Boards) completing the work in all respects in five Marketing Yard's viz Musallahpur (Patna), Gulabbagh (Purnea), Biharsharif (Nalanda), Gaya & Muzaffarpur for display of rates of different commodities/crops/vegetables which are dealt/sold/purchases in the marketing yards on daily basis including its maintenance as per the terms and conditions, after submission of Performance Security Deposit. All the pages of tender document and supply order will also be part of contract agreement and annexed with the agreement form duly signed.
3. BSAMB (D) reserve the right to increase/decrease the number of Electronic Display board for different marketing yards or increase the number of location of marketing yards where necessity for installation of electronic display board (LED) is felt. In such case, the agency will have to execute the work at such additional locations at the same rate and terms and condition accepted for the five marketing yards mentioned in the original tender document.
4. In the event of any questions/dispute of difference arising between BSAMB (D) and the agency, on any matter covered by the agreement, the matter shall be referred to the Principal Secretary, Department of Agriculture, Government of Bihar for arbitration. However, the matter may be referred to High Court of Patna if the dispute is not sorted out at level of Principal Secretary.
5. BSAMB (D) will not be responsible for losses incurred to the supplier/bidder due to change in Govt. Decision, natural calamities, which are beyond the control of BSAMB (D).
